REMARKS FROM THE CHAIRPERSON – Tremaine S. Wright

The Chair welcomed back everyone including the new Board members.

She gave an update on some of the issues that was addressed over the summer. Ms. Wright reported that the bus shelters on Franklin Avenue between Lefferts Place and Fulton Street will be moved forward closer to the curb. There will also be an art project will be done on the wall. The elevator shaft will be cleaned. In addition, the area near the Citi bikes on Lefferts Place will receive lighting.

1st Vice-Chair, Oma Holloway chaired the meeting after the departure of the Chair.

ACKNOWLEDGMENT OF ELECTED OFFICIALS/CBO'S

Shelton Jones – Hon. Kenneth Thompson

Mr. Jones gave an update on some of the events that took place over the summer such as:

The gun buyback in August resulted with 59 guns being collected. Another update on an arrest from last year regarding gun trafficking from Atlanta and Pennsylvania to New York, five people were convicted to 10 years in prison. In addition, a Brooklyn man was sentenced to 18 years for stealing homes from residents in Bedford-Stuyvesant. Metin Sarci – Hon. Stephen Levin

Mr. Sarci announced that Mayor De Blasio signed a bill which was sponsored by Council Member Levin. The bill bans the waste that comes from hydraulic fracking in the City. It will go into effect within 90 days.

Neighborhood Assemblies for Participatory Budgeting process will be held shortly. He asked everyone to participate to voice their opinion.

Carl Luciano – Hon. Darlene Mealy

Mr. Luciano stated that Council Member Mealy offers Free Legal Service three times a week in the Council Member's office. He added the summer concerts were very successful.

Dr. Torian Easterling – Asst. Commissioner, DOHMH

Dr. Easterling gave an update on the plans for the District Health Department office. He stated that Woodhull will operate a clinic in the building beginning in 2017. He informed the audience that the Health Department along with NYPD is investigating the recent outbreak of the K2 and the stores that sell K2. If anyone has information on the sale of K2, please call 311 to report it.

He also spoke about the Zika Virus saying that New York City is number two in the country after Florida with the number of case (510) reported. Brooklyn is second borough with the highest number of cases reported. Mosquito season ends in November. Dr. Easterling advised everyone, especially pregnant women to be careful when travelling to place like Jamaica.

Kathleen Daniels – Hon. Eric Adams

Ms. Daniels informed that the Annual Resource Fair will be held on September 29th, at Borough Hall. It will begin at 5:30 p.m. There will be several agencies on hand.

She announced the Smart Gun Competition is offering \$1 million to the best college/university team with the best design. Borough President Adams is encouraging the project because it allows gun holders to use their thumb print to fire the gun, making it impossible for unauthorized user to fire the gun.

Borough President Adams and Council Member Mark Treyger has advanced legislation on August 16th, to allow parents to open a 529 College Savings Plan immediately upon receiving the child's birth certificate.

In addition, the Borough President and the Brooklyn Arts Council is offering \$1500 Mini Grants for small cultural organizations to help promote the Cultural organization and to help promote tourism in Brooklyn., tourism

Nicole Wright – Hon. Robert Cornegy, Jr.

Council Member Cornegy had two bills passed:

The Commercial Tenants Harassment Bill protects tenants from unscrupulous landlords.

The Lactation Bill requires all City agencies to provide a room for breastfeeding mothers.

She added that Participatory Budgeting has begun. The first neighborhood assembly will be held at the Macon Branch Library at 6:00 p.m., on September 15th.

Daniel Fisher – 81st Precinct Community Council

Mr. Fisher announced that he is the newly appointed President of the Precinct Council. The next meeting will be held on September 13th, at the Multi-Service Center, 1958 Fulton Street.

Ismene Speliotis – Forest City Ratner

Ms. Speliotis announced the deadline to apply for an apartment in 535 Carlton Avenue is September 15th. The lottery is open to households earning \$20,126 - \$173,415. There will be an information session on Tuesday, September 13th, at P.S. 9, 80 Underhill Avenue, from 6:30 p.m., – 8:00 p.m.

DISTRICT MANAGER’S REPORT – Henry L. Butler

Mr. Butler reported that the organization Breaking Ground has not submitted their RFP for the proposed Drop-in Center at 1217 Bedford Avenue. There was a good turnout for the forum held on the situation where residents expressed their concerns. Everyone is against the project.

I. INFORMATIONAL PRESENTATION

A. Health & Social Service Committee:

The Rogosin Institute gave a presentation on kidney health care, hypertension, diabetes and organ donation
Edna Johnson, Committee Chair introduced Molly Phillips, Program Manager, Health & Policy

Ms. Phillips informed the audience that Rogosin Institute works with kidney disease patients. There are eight dialysis centers throughout the boroughs (4 in Brooklyn, 2 in Queens, and 2 in Manhattan). They also work with kidney transplant patients. Diabetes and high blood pressure are the number one factors that leads to kidney disease. They are doing outreach to help people understand that there are ways to prevent kidney disease and keeping it healthy. One in three adults are at risk for kidney disease. It is a silent disease.

She stated that the Obama Administration was to increase organ donation and transplant rates. Less than 50% of people are registered. They have been task to increase the rate to 10,000 in New York City. She added that one donor can save eight lives. Surveys were provided.

II. PUBLIC HEARING

A. Parks, Art & Culture Committee

NYC Parks Department is requesting a letter of support for the proposed renovation of the historic building in Fulton Park, including comfort station, colonnade shade structure and plaza

Marion Little, Committee Chair introduced Martin Maher, Chief of Staff.

Mr. Maher stated that the renovation will include new lighting, ADA accessible bathroom, upgrade of the electrical, ventilation and plumbing. The ceiling will be repaired and the floors will be removed. He added that Council Member Cornegy has funded \$2.7 million for the project. A PowerPoint was done. The colonnade building is a historic structure, built in 1910. The plan is to open the building and make it more accessible for public events. Security will be provided. The Parks Department will continue to have office space. Construction will probably begin in the fall 2017 and continue for a year.

Questions were asked about the type of materials to be used in the renovation also the type of lighting.
